What is it? ➔	This is a Certificate which certifies that your company is in existence, authorized to transact business in the state of NC, and complies with all state requirements.	This poster is a state and federal mandated employment law notice that informs employees of their rights under the NLRA (National Labor Relations Act).	Employer Identification Number, also called a <b>Federal Tax ID</b> , is a 9 digit number associated with your business and is issued by the IRS when you register.
Why do I need it? ➔	It may be required for loans, to renew business licenses, to open your business bank account, or for tax and other business purposes. It shows that your company may legally conduct business in the state of North Carolina.	It is <b>required by Federal Law 29 USC Sec. 666 (I) &amp; 29 Sec. 2005</b> to be posted in a visible location of the workplace for businesses with at least 1 employee. Penalties can lead to <b>fines in excess of \$7,000</b> per instance or even <b>lawsuits</b> .	All businesses are required to register with the federal government and obtain an EIN. An EIN is also required to hire employees, open a business bank account, file taxes, apply for business loans / lines of credit, and other business purposes.
