Notice of Request for Early Review by Rules Review Commission & Right to Object

May 10, 2017

Notice: We have asked the Rules Review Commission to reschedule its review of our final classifications for four sets of rules to an earlier date. **You have a right to submit public comments on our request for early review of our final rule classifications.**

Explanation: Over the past few years, we have conducted a required review of our existing rules in the N.C. Administrative Code.¹ We have finished our review of the last of the rules. Our review included a period when the public could submit comments on our initial classifications of the rules listed below. We did not receive any public comments.

We have now submitted our final classifications of the rules to the N.C. Rules Review Commission (RRC). Our final rules classifications are the same as the initial classifications. Two chapters of the rules are scheduled to be reviewed by the RRC in October 2017 and the other two are scheduled for review in 2018. We are asking for review in July 2017 instead of on the scheduled dates. A list of the rules for which we are requesting early review is at the end of this notice.

The RRC will consider objections from the public when it decides whether to grant our early review request. **You have a right to submit public comments on our request for early review of our final rule classifications.**
